Taula del Tercer Sector (Third Sector Platform) is the main third sector-umbrella organization in Catalonia. We provide a platform for collective action to 35 NGO networks and 3.000 non-profit organizations. Third sector organisations play a key role in bringing about social rights and empowering people and communities through local action.

Taula stimulates and further develops the added value of third sector organisations in society: their capacity to lead social innovation processes and to improve public policies for a fairer society. Our two main areas of work are political advocacy and supporting the third sector.



OUR APPROACH TO INTERNATIONALIZATION

We are all witnessing a historical moment characterized by the overlapping of multiple global transitions: ecological and technological, social and economic. Our territories often interact with the opportunities these processes bring, but above all with the challenges they also create or exacerbate. Its impacts are particularly felt by the most vulnerable groups and, increasingly, by a large social majority. More and more people are at risk of being left behind.

Third sector organisations, which have always been characterized by their collective organization capacity in favour of social improvement, are deeply related with these global dynamics. First, they must provide answers to ever greater social needs, exacerbated by major transitions. Second, they interact more and more often with frameworks of decision and governance, but also of opportunity and alliance, which are increasingly integrated and global.

SHARED AGENDAS AND SOCIAL ALLIANCES

Faced with this scenario, we commit to raise our vision and ambition to a European and transnational scale. We want to understand and interact with these global processes that affect us as a sector and the people we care for. We want to participate in the localization and improvement of European social agendas. And we want to harness the opportunities they raise for improving societies and territories, but most important, the lives of people.

We believe in the potential of alliances to advance this proposal, which is essentially collaborative. We want to work with relevant stakeholders and social organisations from all over Europe and the rest of the world to promote local social responses to the great challenges of the present. We want to participate in the improvement of welfare states and democracy: starting from our territory, based on the values that bring us together and with global responsibility.

We will generate spaces for knowledge exchange and learning between social organisation through study visits and reports. We want to improve our knowledge of other realities and give rise to specific collaboration opportunities between social organisations from Catalonia, the EU and beyond.

Co-create social alliances between worldwide CSOs

We want to co-create shared positions between social organizations from different territories on the social needs that the great transitions of the moment exacerbate and the role of social organisation in addressing them. We want to highlight the role of social organizations in ensuring that these transitions do not leave anyone behind and improve the public recognition of our sector.

OUR SECTOR IN DEPTH

The third sector represents a global reality of social organization, well understood in many other parts of the world, which has always been rooted in Catalonia. Today it works in favour of 1,500,000 people living in Catalonia, with a social base of half a million members, 348,000 volunteers and 85,000 workers.
